SUMMARY

Final Offer Price

The Offer Price has been determined at HK\$1.00 per Offer Share (exclusive of brokerage fee of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

Net proceeds from the Share Offer

Based on the Offer Price of HK\$1.00 per Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting commissions and other estimated expenses payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$68.1 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future Plans and Proposed Use of Proceeds” in the Prospectus.

Applications under the Public Offer

A total of 6,248 valid applications were received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through **electronic application instructions** given to HKSCC via CCASS and through the **eWhite Form** Service Provider under the **eWhite Form** service for a total of 111,357,000 Public Offer Shares, equivalent to approximately 10.6 times of the total number of 10,500,000 Public Offer Shares initially available for subscription under the Public Offer.
