**GRANT OF WAIVER UNDER RULE 14.41(a) OF THE LISTING RULES

FURTHER DELAY IN DESPATCH OF CIRCULAR  
IN RELATION TO MAJOR TRANSACITON**

Reference is made to the announcements jointly issued by Lion Rock Group Limited and Left Field Printing Group Limited (“**Left Field**”) dated 24 May 2022 and 17 June 2022 and the announcements issued by Left Field dated 15 June 2022, 15 July 2022 and 26 October 2022 in relation to the application of waiver from strict compliance with Rule 14.41(a) of the Listing Rules and delay in despatch of circular (collectively, the “**Announcements**”). Unless otherwise defined, capitalised terms used in this announcement shall have the same meanings as defined in the Announcements.

On 1 November 2022, the Stock Exchange has granted the Waiver. The Stock Exchange may withdraw or change the Waiver if the Company’s situation changes.
